CHAPTER 77

An Act to amend the General and Vocational Colleges Act

[Assented to 10 December 1986]

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

c. C-29,
s. 18.1, am. **1.** Section 18.1 of the General and Vocational Colleges Act (R.S.Q., chapter C-29), enacted by section 27 of chapter 30 of the statutes of 1985, is amended

(1) by striking out the word “the” in the first line of the first paragraph;

(2) by inserting, after the first paragraph, the following paragraph:

Staff
management
policy as “The regulations may require a college to adopt, within such time as the Minister may prescribe, a management policy for the staff described in the first paragraph in order to regulate conditions of employment which are not determined by the Minister. The regulations shall specify what matters the policy must cover and they may prescribe the modalities of consultation on the policy and of its adoption and implementation.”

s. 27, am. **2.** Section 27 of the said Act is amended by replacing the words “ninety days” in the second line of the first paragraph by the words “four months”.

Effect of
regulations **3.** Regulations made by the Government and mentioned in Schedule I to this Act are deemed to have been adopted by the Minister of Higher Education and Science under section 18.1 of the General and Vocational Colleges Act as amended by this Act and they have effect from the date of their publication in the *Gazette officielle du Québec*.

Coming into
force

4. This Act comes into force on 10 December 1986.
