CHAPTER 138

An Act to amend the Act to incorporate the Hôtel-Dieu de Lévis

[Assented to 19 June 1986]

Preamble

WHEREAS the Hôtel-Dieu de Lévis is a corporation constituted by chapter 152 of the statutes of 1954-55, amended by chapter 115 of the statutes of 1964;

Whereas under its charter the Hôtel-Dieu de Lévis is not empowered to acquire, establish, possess, maintain, administer or manage a reception centre and whereas it would be necessary that such powers be granted to it;

Whereas it is expedient that certain provisions of its charter respecting practices that are no longer current be repealed;

Whereas the visitor of the corporation has authorized it to make this application;

1. Section 4 of the Act to incorporate the Hôtel-Dieu de Lévis (1954-55, chapter 152), replaced by section 1 of chapter 115 of the statutes of 1964, is replaced by the following section:

“4. The object of the corporation shall be to acquire, establish, possess, maintain, administer and manage a hospital and a reception centre.”

“**10.** The hospital and the reception centre shall be administered by a board of management established in accordance with the provisions applicable to the board of directors of a hospital centre pursuant to the Act respecting health services and social services (R.S.Q., chapter S-5); the board shall exercise all the powers of the hospital and of the reception centre.”
