## CHAPTER 69

### **An Act respecting Gaspésie Mining Company Limited (No Personal Liability) and Sembec Inc.**

*[Assented to 20 June 1984]*

Preamble

WHEREAS Gaspésie Mining Company Limited (No Personal Liability) having its head office at Montréal was incorporated under the Mining Companies Act (R.S.Q., chapter C-47) by letters patent dated 1 August 1963 and amended by supplementary letters patent dated 21 December 1981 and 2 September 1983;

Whereas Sembec Inc. having its corporate seat at Montréal was incorporated under Part I of the Companies Act (R.S.Q., chapter C-38) by letters patent dated 18 December 1973 and amended by supplementary letters patent dated 18 April 1977;

Whereas Sembec Inc. was continued under Part IA of the Companies Act on 11 February 1982;

Whereas Gaspésie Mining Company Limited (No Personal Liability) and Sembec Inc. wish to amalgamate to form a single company in accordance with Part IA of the Companies Act;

Whereas it is in the interest of Sembec Inc. and Gaspésie Mining Company Limited (No Personal Liability) that they be authorized to amalgamate;

#### THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**1.** Notwithstanding section 123.115 of the Companies Act (R.S.Q., chapter C-38), Sembec Inc. and Gaspésie Mining Company Limited (No Personal Liability) may amalgamate in accordance with Part IA of the said Act.
