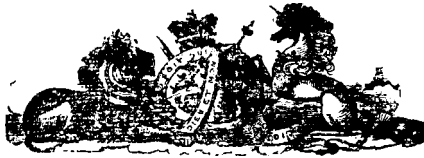

Tuesday, 4th June, 1878.

TUESDAY, the FOURTH day of the month of JUNE, in the forty first year of the reign of Our Sovereign Lady Victoria, by the Grace of God, of the United Kingdom of Great Britain and Ireland, QUEEN, Defender of the Faith, being the First Session of the Fourth Parliament or Legislature of the Province of Quebec, as continued by several prorogations to this day.

At three o'clock in the afternoon, His Excellency the Honorable Luc Letellier de St-Just, Lieutenant Governor of the Province of Quebec, being seated in the Chair on the Throne, the Honorable the Speaker of this House commanded the gentleman Usher of the Black Rod to proceed to the chamber of the Legislative Assembly, and acquaint that House, « It is His Excellency's pleasure they attend him immediately in the chamber of the Legislative Council. »

Who being come thereto.

The Honorable Speaker of the Legislative Council said :

Honorable Gentlemen of the Legislative Council,

Gentlemen of the Legislative Assembly.

His Excellency the Lieutenant Governor, does not see fit to declare the causes of his summoning the present Legislature of the Province of Quebec until the Speaker of the Legislative Assembly shall have been chosen according to law, but to-morrow at the hour of three o'clock in the afternoon, His Excellency will declare the causes of his calling this Legislature.

The Legislative Assembly then withdrew, and His Excellency the Lieutenant Governor was pleased to retire.

The House adjourned during pleasure.

After some time the House was resumed.

The Honorable *Edouard Remillard* presented himself at the Bar of the House and placed in the hands of the Gentleman Usher of the Black Rod, a commission under the Great Seal, summoning him to the Legislative Council of the Province of Quebec.

The Gentleman Usher of the Black Rod having placed his commission in the hands of the Honorable the Speaker he ordered : « that the Honorable Councillor be admitted. »

Then the said Honorable *Edouard Remillard*, accompanied by the Honorable Mr. *de Lery* and the Honorable Mr. *Savage* advanced to the Table and the Honorable the Speaker handed the Commission to the Clerk of this House, who read it as follows :

At three o'clock in the afternoon, His Excellency the Honorable *Luc Letellier de St-Just*, Lieutenant Governor of the Province of *Quebec*, being seated in the chair on the Throne, the Honorable the Speaker of this House commanded the Gentleman Usher of the Black Rod to proceed to the chamber of the Legislative Assembly and acquaint that House : « It is His Excellency's pleasure they attend him immediately in the chamber of the Legislative Council. »

Who being come thereto,

The Honorable Arthur Turcotte said : « May it please Your Excellency, the Legislative Assembly have elected me to be their Speaker, though I do not feel very able to discharge the important duties assigned me. If, in the performance of those duties I should at any time fall into error, I pray that the fault be imputed to me and not to the Legislative Assembly, whose servant I am, and who through me the better to enable them to discharge their duty to the Queen and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to Your Excellency's person at all seasonable times, and that their proceedings may receive from Your Excellency the most favorable interpretation. »

The Honorable the Speaker of the Legislative Council said :

Mr. Speaker,

I am commanded by His Excellency the Lieutenant Gouvernor to declare to you that he freely confides in the duty and attachment of the Legislative Assembly to Her Majesty's person and Government and not doubting that their proceedings will be conducted with wisdom, temper and prudence, he grants, and upon all occasions will recognise and allow their constitutional privileges.

« I am commanded also to assure you, that the Legislative Assembly shall have ready access to His Excellency upon all seasonable occasions, and that their proceedings, as well as your words and actions will constantly receive from him the most favorable construction. »

His Excellency the Lieutenant Governor was then pleased to open the Session by a gracious speech from the Throne to both Houses.

Honorable Gentlemen of the Legislative Council,

Gentlemen of the Legislative Assembly.

It is with pleasure that I see you met together this day for the despatch of the business of this Province.

Our financial condition is the most important of the subjects which you have to consider.

It behoves us to finish the railways already commenced so as to reap, with the least possible delay, the benefit of the sacrifices which we have made to build them.

To carry out these undertakings with success and to meet all our engagements it is indispensable that expenditure should be brought down as low as is consistent with the efficient administration of the public service.

I regret to have to announce that a comparison of our revenue with our expenditure for the eleven months dating from the first of July last, shows a considerable deficit.

Gentlemen of the Legislative Assembly,

The estimates of the next financial year will be submitted to you ; they have been prepared with a view to the strictest economy in order to attain the result to which all our efforts should be directed, that of equalising our receipts and our expenditure without resorting to the levying of fresh taxes on the people.

Honorable Gentlemen of the Legislative Council,

Gentlemen of the Legislative Assembly.

In order to place the finances of the Province on a more satisfactory basis, measures will be submitted to you, the effect of which will be to relieve the budget of several considerable items of expenditure.

A bill will be submitted to you to transfer to the Commissioner of Public Works all the powers now vested in the Railway Commissioners and to put an end to the office.

A measure will be submitted to you to provide for the abolition of the Magistrates' Courts.

You will be called on to take into consideration a bill for effecting a change in the Legislature of this Province in so far as regards the Legislative Council.

Since the last session, judgment was rendered by Her Majesty in Her Privy Council on the question of the arbitration between the Provinces of Quebec and Ontario; a copy of this judgment will be submitted to you.

I entertain no doubt that you will manifest in the fulfilment of your important duties that serious attention, that devotion to the interests confided to you and that loyalty to Our Sovereign Lady the Queen which is to be expected from the Legislature of Quebec.

I ardently pray that heaven may bless your labours and that they may tend to the union, peace and prosperity of the inhabitants of our Province.

The Legislative Assembly then withdrew, His Excellency the Lieutenant Governor was pleased to retire.

The Speaker reported His Excellency's Speech from the Throne and the same was then read by the clerk.

The Order of the Day was read for taking into consideration the speech of His Excellency the Lieutenant Governor from the Throne, at the opening of the session, and

The speech being read by the clerk,

Hon. Mr. *Remillard*, seconded by Hon. Mr. *Proulx*, moved that an humble Address be presented to His Excellency the Lieutenant Governor to thank His Excellency for his Gracious Speech at the opening of the First Session of the Fourth Parliament of the Province of Quebec, and further to assure His Excellency .—

“ 1. That we beg His Excellency who sees us, with pleasure, met together for the despatch of the business of this Province, to rest assured that we will give the greatest attention to such business.

“ 2. That, with His Excellency, we believe our financial condition to be the most important of the subjects which we have to consider.

“ 3. That, with His Excellency, we are of opinion that it behoves us to complete the railways already commenced, so as to reap, with the least possible delay, the benefit of the sacrifices we have made to build them.

“ 4. That to carry out these undertakings with success and to meet all our engagements, it is indispensable that expenditure should be reduced as low as is consistent with the efficient administration of the public service.

“ 5. That we will carefully consider the bill which will be submitted to us, to transfer to the Commissioner of Public Works all the powers now vested in the Railway Commissioners and to abolish the office.

“ 6. That we will attentively consider the measure which will be submitted to provide for the abolition of the District Magistrates' Courts.

“ 7. That we will give all our attention to the bill which will be submitted to us for effecting a change in the Legislature of this Province in so far as regards the Legislative Council.

« 8. That we look forward with interest, to the communication of the judgment rendered, since last session, by Her Majesty in Her Privy Council, on the question of the arbitration between the Provinces of Quebec and Ontario.

« 9. That His Excellency may rest assured that we will manifest, in the fulfilment of our important duties, that serious attention, that devotion to the interests confided to us, and that loyalty to Our Sovereign Lady the Queen, which is to be expected from the Legislature of Quebec.

« 10 That with His Excellency, we ardently pray that Heaven may bless our labours and that they may tend to the union, peace and prosperity of the inhabitants of our Province. »

The first paragraph being again read, the Honorable Mr. *Remillard* moved, seconded by the Honorable Mr. *Proulx*, that it be adopted.

« We although convinced of the serious danger to the rights and liberty of the Province of Quebec by any modification to the British North America Act, we will however give all our attention to the British North America act which will be submitted to us to that effect.

« We look forward with interest, to the communication of the judgment rendered, since last session, by Her Majesty in Her Privy Council, on the question of the arbitration between the Provinces of Quebec and Ontario.

« Your Excellency may rest assured that we will manifest, in the fulfilment of our important duties, that serious attention, that devotion to the interests confided to us, and that loyalty to our Sovereign Lady the Queen, which is to be expected from the Legislature of Quebec.»

But that this House desires to express a new its regret that Your Excellency, was advised to dismiss Your Ministers in March last, at the time they enjoyed the confidence of both branches of the Legislature and of the Province.

That this House is of opinion that in acting on this advise dismissing your ministers, and appointing a new cabinet from the ranks of the minority, your Excellency was advised to follow a course contrary to the recognized principles of responsible government.

Hon. Gentlemen and Gentlemen.

« To say that I am deeply moved by the address with which the two House of the Quebec Legislature have honored me, is to express but very little of what I feel, for at such a moment I cannot help remembering that it was when landing on your shores six years ago, I was made to feel for the first time amongst what a loyal, cultivated and generous people I had come to take up my abode. Certainly no Viceroy could have entered upon his career under happier auspices than those which you had prepared for me.

« Since that time Lady Dufferin and myself have had the happiness of frequently returning to our summer home within your lofty Citadel, and each year that home has become endeared to us by ever brightening associations, and the cementing of closer friendship.

Year by year, I have had better opportunities of appreciating the devotion of the inhabitants of the Province of Quebec to the throne and government of the Queen, and to the interests of the Empire; and nothing has given me greater pride than to observe when a cloud of war recently threatened Great Britain that Her Majesty's French Canadian subjects were not a whit behind their English, Scotch and Irish fellow citizens, in testifying to their willingness to rally to the defence of Her Dominions.

« It is quite true that the distinctions of race which exist within the borders of Canada complicate to a certain degree those problems of Government with which the statesmen of the country are periodically called upon to deal, but the inconveniences which may sometimes arise from this source are more than counter-balanced by many advantages which ensue from it. I do not think that ethnological homogeneity is an unmixed benefit to a country. Certainly the least attractive characteristic of a great portion of this continent is the monotony of many of its outward aspects, and I consider it fortunate for Canada that her prosperity should be founded on the cooperation of different races. The inter-action of national idiosyncrasies introduces into our existence a freshness, a variety, a colour, an eclectic impulse, which otherwise would be wanting; and it would be most faulty statesmanship to seek their obliteration. My warmest aspiration for this Province has always been to see its French inhabitants executing for

Canada the functions which France herself has so admirably performed for Europe. Strike from European history the achievements of France—substract from European civilization the contributions of France, and what a blank would be occasioned !

« I am very sensible of your goodness in referring in such flattering terms to my humble endeavours to promote the embellishments of your city, by the preservation and adornment of your picturesque and world-famous battlements. Though various circumstances have postponed the execution of the project, I am happy to be able to announce that ere many days pass by, a commencement will have been made, not without advantage I trust to those of our fellow citizens who in these recent times of distress, have found a difficulty in obtaining employment.

« In conclusion allow me to express to you in Lady Dufferin's name, her deep sense of the compliment paid to her in your address. In no part of the Dominion has she met with greater courtesy, with more chivalrous and considerate attention than in the city of Quebec, and never will its picturesque outliness, or the lovely scenery which surrounds it, fade from her memory or from mine. »

1. 2. Because when paragraph 5 of the article 712, was enacted, the grants in favor of railways subsidized were payable during a term of twenty years, and the intention of the paragraph was to grant an additional aid by exempting them from municipal taxes for the same period. And that afterwards the grants were made payable in a block sum per mile, and because the amendment contained in section 27 is intended to afford to subsidized railways such further aid by giving them such exemption from taxes for twenty years, notwithstanding the change in the manner of paying the grants ; and because the section renders the intention of the legislature clear, and removes doubts which now exist.

3. Because in the number of municipalities, the valuation rolls cannot be made, this year, before the end of July, and it is expedient and right to afford the relief contained in section 42, which allows the valuation rolls to be made this year, at any time, before the 1st Sept. next.

4. Because it is urgent that sections 25, 26 and 42 should come into force immediately, and consequently that the act do come into force on the day of its sanction.

Ordered, That Mr. Wurtele, the Hon. Solicitor General Chanveau, Messrs. Gagnon, Martel and Flynn do go to the Legislative Council and desire the said conference.

I have been deeply gratified by the Legislative measures which you passed during this session and particularly by that which, ensuring to this Province a reduction in the general expences, looks to a re-establishment of an equilibrium between our income and our expenditure.

You have proved by your important deliberations the value which you attach to the benefits of the constitutional system, under which we are governed, a system which confers upon the people of this province the inalienable right of being consulted on all matters connected with their interests.

Gentlemen of the Legislative Assembly.

I thank you for the liberality with which you have voted the supplies, and I shall take care that they are wisely expended with a view to the greatest advantage of the people of this Province.

Honorable Gentlemen of the Legislative Council,

Gentlemen of the Legislative Assembly.

I beg of you to accept the good wishes which I offer for your welfare and for the general prosperity of this Province ; prosperity which can only be assured by the respect of all for constituted authority and by the maintenance of peace and order of which you are the chief guardians.
